Program Administration

The 1st Annual Board Meeting

- 1. The 1st Annual Board Meeting of the e-ASIA Joint Research Program (the "Program"), chaired by Dr. Takayoshi Mamine, Japan Science and Technology (JST), was held on 28 June 2012 in Singapore at Mandarin Orchard Hotel.
- 2. The meeting was attended by six Board Members from six Members of the Program, namely, RISTEK of Republic of Indonesia, MEXT of Japan, MOST of Lao People's Democratic Republic, MOST of Republic of the Union of Myanmar, NSTDA of Kingdom of Thailand and MOS of Socialist Republic of Viet Nam, with guest speakers from Japan and Kingdom of Thailand and observers form MOD of Brunei Darussalam, MIME of Kingdom of Cambodia, Embassy of People's Republic of China in Singapore and A*STAR of Republic of Singapore.

Formal inauguration of the Program

3. The attending six Board Members confirmed the concept of the Program and the Members at the time of inaugurating the Program. On 28 June 2012, the Program was formally inaugurated and the Statute of the Program was adopted.

Program Secretariat

4. The Board acknowledged that the tentative Program Secretariat had been in operation through support from JST of Japan which would continue for three

- years. For long-term sustainability, detailed mechanism should be discussed at the next Annual Board meeting.
- 5. Tentative location of the Program Secretariat is in Biopolis, Singapore. Formal location is subject to Member's offer.
- 6. As of June 2013, the Program Secretariat consists of 1 Secretary-General, Mr. Osamu Kobayashi, and 1 staff member, Ms. Eriko Kishida, both from JST of Japan.

The 1st ad hoc Board meeting

- 7. The 1st ad hoc Board meeting was held via email sent to the Board members on 28 September 2012.
- 8. The topics that were approved by the Board are:
 - (1) 2nd Pilot Joint Calls for Proposals
 - (2) Symposium to be held in December in Singapore
 - (3) Additional Project to be approved from the 1st Pilot Joint Call for Proposals.

- 9. The 2nd ad hoc Board meeting was held via email sent to the Board members on 6 February 2013.
- 10. The topics that were approved by the Board are:
 - (1) Program related documents
 - Scientific Advisory Council Terms of Reference
 - Peer-Review Panel Terms of Reference
 - Guideline/Template of Collaborative Research Agreement
 - Guideline/Template of Joint Application Agreement for Intellectual Property Rights
 - Guideline/Template of Material Transfer Agreement
 - (2) Formal participation of the Ministry of Health, Cambodia
 - (3) Future activity plans (2nd Pilot Joint Calls for Proposals, 2nd Annual Board Meeting and Workshop in Lao PDR)

The 3rd ad hoc Board Meeting

- 11. The 3rd ad hoc Board Meeting was held via email sent to the Board members on 15 March 2013.
- 12. The participation of the National Institute of Allergy and Infectious Diseases (NIAID) of the United States was formally approved by the Board.

The 2nd Annual Board Meeting

- 13. The 2nd Annual Board Meeting was held on the 5th of June in Jakarta, Indonesia.
- 14. The Chair of the meeting was the Ministry for Research and Technology (RISTEK) of Republic of Indonesia.
- 15. Those items that have been approved by the Board through ad hoc Board Meetings were reviewed at the 2nd Annual Board Meeting.
- 16. Other topics that were discussed at the Meeting include amendment of the Program Statute and sample Letter of Intent (LoI), guideline for the participation of new Members, basic functions and composition of the Program Secretariat including its location, final projects selection from the 2nd Pilot Joint Call for Proposals in the fields of "Infectious Diseases", future Call for Proposals, Call flexibility, selection and appointment of Scientific Advisory Council members, future activities of the Program, etc.
- 17. A Workshop on "Disaster Prevention" was held on the preceding day.

Joint Call for Proposals

The 1st Pilot Joint Calls for Proposals

- The 1st Pilot Calls for Proposals were conducted in the fields of "Nanotechnology and Materials" and "Biomass and Plant Science" among NSTDA of Kingdom of Thailand, MOST of Socialist Republic of Viet Nam and JST of Japan in May 2012.
- 2. Out of 14 proposals received, 11 for "Nanotechnology and Materials" and 3 for "Biomass and Plant Science", the two projects "Plasmonic bio-sensor for detecting serious diseases in Southeast Asia" and "Advancement of Asian Cassava Molecular Breeding by Cutting-edge Technologies" were approved by the Board to receive fund from NSTDA of Kingdom of Thailand, MOST of Socialist Republic of Viet Nam and JST of Japan.
- 3. In addition to the 2 projects mentioned above, NSTDA of Kingdom of Thailand, MOST of Socialist Republic of Viet Nam and JST of Japan decided to fund the third project "Corrosion Mapping of Structural Materials in Asian Area with Understanding Effects of Environmental Factors".

The 2nd Pilot Joint Call for Proposals

- 4. The 2nd Pilot Joint Call for Proposals was conducted in the field of "Infectious Diseases" among DOST of the Philippines, MOST of Socialist Republic of Viet Nam and JST of Japan from February to April 2013.
- 5. As of June 2013, final project selection is subject to subsequent internal process and final approval by the three agencies involved, as well as the Board's decision.

Next Joint Call for Proposals

6. Another Joint Call for Proposals, in the field of "Functional Materials", is planned to be conducted after the 2nd Annual Board Meeting. Interested Members (NSTDA of Kingdom of Thailand, MOST of Socialist Republic of Viet Nam and JST of Japan) are now discussing the necessary arrangements.

Researcher Interaction

<u>Scholarship</u>

 Starting in November 2012, research students who are nationals of an e-ASIA JRP member country and who wish to pursue a PhD are eligible to apply to the Japanese Government (MEXT) Scholarship program within the e-ASIA framework. Applications from e-ASIA JRP member countries are being encouraged.

The 1st Symposium

- 2 The first Symposium, sponsored by JST and supported by RIKEN and Japanese Embassy in Singapore, was held on December 4, 2012 at the Regent Hotel Singapore. About 90 people from several East Asian countries attended this event.
- 3. At the symposium, participants were researchers from the East Asian countries working in the cooperation fields of "Infectious Diseases," "Disaster Prevention" (research fields which were not covered in the 1st pilot call for proposals) and "Advanced Interdisciplinary Research toward Innovation" (new field) and the following objectives were targeted:
 - a. Promotion of applications to the 2nd Pilot Call for Proposals;
 - b. Creation of potential international joint research teams of young

researchers;

- c. Dissemination of the Program to researchers in East Asian countries (including non-member countries).
- 4. Opening remarks and the keynote speech were delivered by Mr. Masaaki Tanaka, Senior Deputy Director-General of the Ministry of Education, Culture, Sports, Science and Technology of Japan (MEXT) and Prof. Teruo Kishi, Program Director at Japan Science and Technology Agency (JST) respectively.

- 6. The following day, breakout workshop sessions were held for each field. To find out the most appropriate themes of collaboration, to promote creation of potential international joint research teams, and to encourage participants to submit joint proposals for the expected joint call for proposals, these workshop sessions provided a platform for representatives from each country to present their interests and to discuss various aspects of the fields of "Infectious Diseases", "Disaster Prevention" and "Advanced Interdisciplinary Research towards Innovation".

"Infectious Diseases" Science Talk Luncheon

- 7. On March 12th 2013, JST sponsored a Science Talk Luncheon during the 'U.S.-Japan Cooperative Medical Sciences Program Regional Conference on Emerging Viral Diseases 2013' organized by NIAID in Singapore.
- 8. This luncheon aimed to introduce the e-ASIA JRP to the event participants and to further explore what opportunities there are for multilateral cooperative research in the field of Infectious Diseases in the East Asian region.
- 9. After a brief self-introduction, the 11 participants from the region were separated into 3 groups according to their specialism (1. Rotavirus and Gastroenteritis, 2. Dengue Fever and 3. Hepatitis) in order to discuss potential opportunities for international cooperation in their field.
- 10. Summaries of the discussions held at each table were distributed via email and are also posted on the website.

Workshop in Indonesia

- 11. Back-to-back with the 2nd Annual Board Meeting, a workshop on "Disaster Prevention " was held on the 4th of June in Jakarta, Indonesia.
- 12. The objectives of this Workshop are to disseminate information on the e-ASIA Joint Research Program and to promote researcher interaction in the region.

Workshop in Lao PDR

- 13. JST is now consulting with the Ministry of Science and Technology (MOST) of Lao PDR to co-host a workshop at the end of July or the beginning of August this year.
- 14. The proposed theme is "Biomass" or "Alternative Energy".

Ongoing Projects

There are 3 ongoing projects (2 and 1 are respectively in the fields of "Nanotechnology and Materials" and "Biomass and Plant Science") as of June 2013. All of the 3 projects receive funding from NSTDA of the Kingdom of Thailand, MOST of the Socialist Republic of Viet Nam and JST of Japan.
